Scope of Work

Counselors are responsible for supervision, safety, and overall experience of campers involved in the Southborough Recreation Summer Day Camp system. Counselors will be tasked with implementing programming, policies, and procedures as directed by the Camp's Supervisor or his/her designee. Interaction with parents, guardians, and caregivers will be mandatory. This is a seasonal position with an expectation of working 7-10 weeks during the summer.

Essential Job Functions

- Communicate with parents about participant's experiences and report concerns to Supervisor
- Assist in maintaining accurate program records including incident reports, daily attendance, and inventory of supplies
- Know and understand all emergency procedures associated with the camp program
- Work complimentary with other camp counselors to ensure a successful experience for all campers and staff alike.

• First Aid/CPR Certified. Not required but preferred. Training will be offered if non-certified.

- Work is performed in an indoor and outdoor setting. Must be able to perform tasks of instruction as they relate to the assigned duty
